Go into “My Profile” and make sure all information is current, especially your e-mail address. To review the POOLS, you will again go to WWW.myohsaa.org home page. You will see below the mission statement multiple boxes to click on, you will put your curser on officiating and a drop down menu will appear, at this point you click on Officiating – Home, scroll to Game Assignments and click, scroll to the bottom where you will see OHSAA Officials Tournament Voting Results, click on wrestling.
